- providing high quality programs and resources for classroom and specialist programs

- maintaining and developing the school grounds
- contributing to our Little Learners Love Literacy program
- providing individual student supplies and class bulk supplies

The Department of Education does **<u>NOT</u>** allocate additional funds to our school for the purchase of stationery, classroom, and specialist consumable materials. We supplement the parent voluntary contributions with the funds we receive for our student programs from the Department of Education.

The average cost for the purchase of stationery, classroom, and specialist consumable materials is approximately \$70,000 a year. To put this into perspective this is equivalent to having each year:

- a new playground or
- 100 new student laptops or
- one extra teacher or
- 2 Educational Support staff and so on...

This is why voluntary contributions families make are greatly appreciated and have a significant benefit to the joy and learning of all our students.
